Privacy Act Changes

You'll have probably seen the notifications that the Privacy Act Amendments came into effect 12 March. There are new privacy compliance requirements that you should be aware of if you collect client information and the Australian Government business website has some great info.

You need to first check whether your business is affected by the changes. From the website:



"The Privacy Act protects personal information handled by large businesses and health service providers of any size.

The Act may apply to a small business if it has an annual turnover of more

than \$3 million and either:

trades in personal information.

8 April 2014 sees the end of Microsoft's support for Office 2003 and Windows XP so if you've not upgraded to Office 2007, Office 2010 or Office 2013, you might think about doing so now. All three versions support the old formats of Office documents (.doc, .xls etc) so you'll be able to open your old documents. Your old software will continue to work post D Day, but ending support means the end of updates - and critically, security updates - and we all know how susceptible to security exploitation MS products are.

Microsoft has released its Office for iPad app which includes Word, Excel and Powerpoint.

Anyone can download the app and use it to read/view Office documents for free but to edit documents you need an Office 365 subscription (AU\$119/year). Apparently you can save to your iPad but your only other option is the Microsoft cloud solution OneDrive (formerly SkyDrive) with no support for any other cloud-based storage solution. Gizmodo has a pretty good overview of the features here including a video walk through. Office Watch have also road tested the app and include cover of Word and Excel on their Office Watch site.

With the release of the app, Microsoft made a change to the Office 365 Home subscription now allowing download of the app to an unlimited number of mobile devices (previously limited to five). And apparently on the same day as the Office for iPad release, Microsoft also updated Office Mobile for iPhone and Android, and according to their blog it's 'free for everyone'. (Does that mean it's not worth charging for?)

One thing to consider is the limitation around saving to OneDrive only. Recently Office Watch wrote that Microsoft can legally read your Office documents with their Terms of Use stating they can access your OneDrive documents anytime for any reason without notice. Password protecting them doesn't help since Office mobile apps and Office Web apps can't open password protected documents. Granted, other cloud storage service providers like Google have similar wording in their Terms of Use too, but apparently Microsoft was recently found to be actually using those powers for its own benefit. You can read the story of how they accessed a user's private email searching for evidence here .

I have to say for iPad I've found that the **Docs Unlimited** App works just fine for what I need to do in Word and Excel. I can easily edit documents, print and email them. There is a free version and a paid version but at only \$5.49 the paid version is a bargain.

But my absolute stand-out favourite is **CloudOn** - available for iPad and Android devices it gives you access to documents in a variety of cloud-based storage locations including Dropbox, Box, Google Drive, SkyDrive and Hightail. Easily create Word, Excel and Powerpoint documents, save them in the selected cloud storage location, print using AirPrint, send via email or invite more editors to the document. You do need an internet connection for the service and sign up for an account, but it is very easy to use and saves in the correct format.
